**CREATING THE FACT FINDING COMMITTEE IN RELATION TO THE ADMINISTRATIVE CASE
FILED AGAINST ANY OFFICIAL OR EMPLOYEE OF THIS LOCAL GOVERNMENT UNIT**

WHEREAS, the Local Government Code of 1991 also known as RA 7160 states in Sec.444 (X) that the Local Chief Executive shall ensure that all executive officials and employees of the municipality faithfully discharge their duties and functions as provided by law and this code and cause to be instituted administrative or judicial proceeding against any official or employee of the municipality who may have committed an offense in the performance of his official duties;

WHEREAS, the performance of duties and functions of all government officials and employees are under the Civil Service Laws and Rules that has corresponding penalties or punishment if any official or employee violates the said rules and laws;

WHEREAS, the creation of the fact finding committee is imperative to protect our public service, interest, and welfare of this Local Government and our constituents;

WHEREAS, the fact finding committee shall perform its duties and functions to investigate and make report regarding on administrative case filed against any official or employee of this Local Government Unit ;
