**EXECUTIVE ORDER NO. 03s. 2013**  
**ORGANIZING LOCAL AIDS COUNCIL**

**WHEREAS**, the general welfare as stated under Section 16 of RA 7160 better known as the Local Government Code of 1991 provides that the basic services including health and safety services be delivered by the Local Government Units for the purpose of having a healthy citizenry;

**WHEREAS**, the disease, Human Immunodeficiency Virus/Acquired Immune Deficiency Syndrome (HIV/AIDS) recognizes no territorial, social, political and economic boundaries for which there is no known cure;

**WHEREAS**, in support to the prevention and control of HIV/AIDS, RA 8504 entitled, "The Philippine AIDS Prevention and Control Act of 1998 was enacted to counter the threat of HIV/AIDS epidemic by promulgating related necessary policies and strategies and to monitor the implementation of this act down to the local levels;

**WHEREAS**, as front liner in the delivery of basic services to our constituents, the creation of Local AIDS Council is imperative board to prevent, mitigate and eradicate the conditions that fuel the spread of HIV/AIDS;

**NOW THEREFORE, I, ROLANDO S. BUE**, Municipal Mayor of Gabaldon, Nueva Ecija, Province of Nueva Ecija, by virtue of the powers vested in me by existing and applicable laws do hereby order the following;

**SECTION II. *Duties and Responsibilities of the Local AIDS Council.*** The council shall be the Central Advisory, Planning and Policy Making Body for the comprehensive and integrated HIV/AIDS prevention and control program of the Local Government Unit, Gabaldon, Nueva Ecija.

The council shall perform the following:

- a. Formulate policies and strategies for the prevention and control of HIV/AIDS and STD like conduct of public awareness and education;
- b. Prepares/Develops HIV/AIDS prevention and control program and monitor its implementation;
- c. Identify and prepare remedies to problem about program implementation and coordination and enhance local multi-sector response to HIV/AIDS and STD concerns;
- d. Proposes related ordinances and resolutions for approval of the Sangguniang Bayan,
- e. Recommends to the office of the Municipal Mayor the closure of any establishment found to be violating the provisions of pertinent laws and ordinances; and
- f. Coordinates and cooperates with national government and other organizations regarding data collection, research and treatment modalities concerning HIV/AIDS.

**SECTION III. MEETING OF THE LOCAL AIDS COUNCIL.** The LAC shall meet quarterly on date and time to be set by the body. The chairman may call a special meeting if. Necessary.

**SECTION IV. EFFECTIVITY.** This EO shall take effect immediately.
