**CREATION OF INVESTIGATING COMMITTEE IN RELATION TO THE COMPLAINT
OF MR. RONOLFO S. BAUTISTA AGAINST MR. CELESTINO G. MANGULABNAN**

WHEREAS, Mr. Ronolfo S. Bautista filed a complaint against Mr. Celestino G. Mangulabnan in the Office of the Ombudsman;

WHEREAS, the Office of the Ombudsman referred to this office the complaint thru First Endorsement, dated December 13, 2012 and states that under Section 23 of the Republic Act No. 6770, the Office of the Ombudsman, at its option, may refer certain complaints to the proper disciplinary authority for the institution of appropriate administrative proceedings against any public officers or employees;

WHEREAS, on the said endorsement also asserts Section 86 of Republic Act No. 7160 provides that in any local government unit, administrative investigation may be conducted by a person or a committee duly authorized by the Local Chief Executive. Said person or committee shall conduct hearings on the cases brought against appointive local officials and employees and submit their findings and recommendations to the Local Chief executive concerned within fifteen (15) days from the conclusion of the hearings. The administrative case shall be decided within ninety (90) days from the time the respondent is formally notified of the charges.

WHEREAS, it is imperative to create the Investigating Committee about the complaint of Mr. Ronolfo S. Bautista against Mr. Celestino G. Mangulabnan to clarify the grievance and issue occurred and to renew the good relation of both employees for the benefit of this Local Government Unit and its constituents;

NOW, THEREFORE I, ROLANDO S. BUE, Municipal Mayor of Gabaldon Nueva Ecija by virtue of powers vested in me by the constitutions, do hereby order that the Fact Finding Committee be created and shall be composed of the following, to wit;
