EXECUTIVE ORDER NO. 19s. 2013
REORGANIZING THE MANILA BAY CLEAN-UP,
INVENTORY, INSPECTION AND MONITORING TEAM

WHEREAS, pursuant to the continuing Mandamus of the Supreme Court to clean, rehabilitate and preserve the Manila Bay Watershed Areas and to the Department of the Interior and Local Government Office Memorandum, dated August 22, 2013, mandate the reorganization of LGU's Inspection, Inventory and Monitoring Team;

WHEREAS, the urgent need to reorganize the same is necessary and imperative to make the team more effective and proficient in dispensing its duties and functions to protect the Manila Bay Watershed Areas;

NOW, THEREFORE I, ROLANDO S. BUE, Municipal Mayor of Gabaldon Nueva Ecija by virtue of powers vested in me by the constitution and laws do hereby ordered;

Section I. That the LGU Gabaldon, Nueva Ecija, Manila Bay Clean Up, Inspection, Inventory and Monitoring Team is hereby reorganized;

SECTION II. DUTIES AND FUNCTIONS. That the Team shall have the following duties and functions as follows;

- a. Conduct inspection and inventory of all factories (Fs), commercial establishments (CEs) and private homes (PHs) within and outside the easements along shorelines and banks of major and minor river system and waterways within the Manila Bay Area;
- b. Prepare and submit a duly certified list of names of non-complying Fs, CE and Phs;
- c. Monitor the compliance of the same;
- d. Recommend the imposition of necessary sanctions, and penalties to Local Chief executive of all non-complying Fs, CE, and PHs within the Manila Bay Area.

SECTION III. COMPENSATION AND REMUNERATION.

The LGU Gabaldon, Nueva Ecija, Manila Bay Clean Up, Inspection, Inventory and Monitoring Team shall perform their duties as such without additional compensation or remuneration.

SECTION IV. EFFECTIVITY. This Executive Order shall take effect immediately
