EXECUTIVE ORDER NO. 22s. 2013

**REAFFIRMING THE DESIGNATION OF MR. CELESTINO G. MANGULABNAN
AS LOCAL ECONOMIC AND INVESTMENT OFFICER OF THE MUNICIPALITY OF GABALDON, NUEVA ECIJA**

WHEREAS, the Department of the Interior and Local Government issued a Memorandum Circular NO.2010-113, encouraging all Local Chief Executives to designate a Local Economic and Investment Officer for their jurisdiction;

WHEREAS, this Local Government plays an active role in attracting more investment by provision of an enabling environment that will generate and enhance economic activities;

WHEREAS, it is imperative to reaffirm the designation of Mr. Celestino G. Mangulabnan as Local Economic and Investment Officer of this municipality who will play an active role and responsible for economic development of this municipality;

NOW, THEREFORE I, ROLANDO S. BUE, Municipal Mayor of Gabaldon Nueva Ecija by virtue of power vested in me by the constitutions and the laws do hereby order;

SECTION I. DESIGNATION. That MR. CELESTINO G. MANGULABNAN, Municipal Planning and Development Officer is hereby designated as Local Economic and Investment Officer of this municipality;

SECTION II. DUTIES AND FUNCTIONS. The duties and functions of L.E.I.O. are not limited to the following:

1. Facilitates the preparation, coordination, and execution of local economic and investment promotion policies, projects and activities of the municipal government.
2. Facilitates the establishment of an aggressive, systematic, coordinated, sustained promotion and marketing of the LGUs as investment location.
3. Provides basic information about business potentials of the LGU including LGU services to prospective investors to attract more investments to flow in the community.
4. Establishes a local economic data base containing relevant facts and figures.
5. Coordinates with other offices in the promotion of economic activities such as Municipal Treasurers Office and Municipal Budget Office and the local Sanggunian;
6. Coordinates with the private sector in investment promotion campaigns.
7. Conducts information dissemination on local government policies on investment wage laws, required permits, etc.

SECTION III. COMPENSATION AND REMUNERATION. The Local Economic and Investment Officer shall perform his duties as such without additional compensation or remuneration.

SECTION IV. REPEALLING CLAUSE. All executive orders, rules and regulations that are inconsistent therewith shall be deemed revoked, amended and/or amended accordingly.

SECTION V. EFFECTIVITY. This Executive order shall take effect immediately.
