EXECUTIVE ORDER NO. 14 s. 2014

CREATING THE MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN (MCPC) IN THE MUNICIPALITY OF GABALDON, NUEVA ECIJA

WHEREAS, MC No. 2002-121 of the DILG, ordered all LGUs to organize Local Councils for the Protection of Children (LCPCs) and shall take the lead in the implementation of all programs for the protection of children in their respective localities. The council shall be fully harnessed for the efficient and effective implementation of all major areas of concern for children;

WHEREAS, the creation of Municipal Council for the Protection of Children in this municipality is in vital point to ensure all laws and ordinances that would protect children and their rights shall be applied and followed at all cost;

NOW THEREFORE, I, ROLANDO S. BUE, Municipal Mayor of Gabaldon, Province of Nueva Ecija, by virtue of powers vested in me by existing and applicable laws do hereby order that the Municipal Council for The Protection of Children be created and it is composed of the following, to wit;

**SECTION II
FUNCTIONS**

- Formulates plans, programs and policies for children that are gender-fair, culturally relevant and responsive to the needs of diverse groups of children from 0-below 18 years of age;
- Prepares Annual Work and Financial Plan (AWFP) for children and recommend appropriations to the Sanggunian;
- Provides coordinate linkages with other agencies and institutions in the planning, monitoring and evaluation of plans for children;
- Provides technical assistance and recommend financial support to the Municipal and Barangay Council for the Protection of Children:
- Recommends local legislations promoting child survival, protection, participation and development, especially in the quality of television show and media prints and coverage, which are detrimental to children, and with appropriate funding support;
- Conducts capability building program to enhance knowledge and skills in handling children's program.
- Monitors and evaluates the implementation of the program
- Establishes and maintains an MCPC management information system/database;
- Ensures proper documentation of MCPC program/ services;
- Prepares the MCPC program, plan of action and annual investment plan;
- Adopts and implement a system for early childhood surveillance and referral system;
- Organizes and strengthens MCPC coordinating committees at the barangay level;
- Initiates and support local legislation relative to MCPC; and
- Promotes, mobilizes and encourages private sector initiatives.
