EXECUTIVE ORDER NO. 11 s. 2015
REORGANIZING THE COMPOSITION OF THE MUNICIPAL SCHOOL BOARD

WHEREAS, Article 98 of RA 7160 also known as the Local Government Code of 1991 states the creation and composition of the Municipal School Board;

WHEREAS, with the assumption of office of the new set of elected Federation of Parents and Teachers Association and appointment of new District Supervisor, it is deemed necessary to reorganize the Municipal School Board of this municipality;

NOW, THEREFORE I, ROLANDO S. BUE, Municipal Mayor of Gabaldon Nueva Ecija by virtue of powers vested in me by the constitutions and the laws do hereby ordered;

SECTION I. That the Municipal School Board is hereby reorganized.

SECTION II. COMPOSITION AND MEMBERSHIP. The Municipal School Board shall be composed of the following to wit:

SECTION III: The functions of the Municipal School Board as enumerated under Article 184 (b) of RA 7160 is hereby adopted as follows:

- (1) Determine, in accordance with the criteria set by DepEd, the annual supplemental budgetary needs for the operation and maintenance of public schools within the municipality, as the case may be, and the supplemental local cost of meeting such needs, which shall be reflected in the form of an annual school board budget corresponding to its

share of the proceeds of the special levy on real property constituting the special education fund and such other sources of revenue as the Code and other laws or ordinances may provide;

- (2) Authorize the municipal treasurer, as the case may be, to disburse funds from the special education fund pursuant to the budget prepared in accordance with applicable existing rules and regulations;
- (3) Serve as advisory committee to the sanggunian concerned on educational matters such as, but not limited to, the necessity for and the uses of local appropriations for educational purposes; and
- (4) Recommend changes in the names of public schools within the territorial jurisdiction of the LGU of Gabaldon for enactment by the sanggunian concerned.

SECTION IV. MEETINGS AND QUORUM.

- (1) The Municipal School Board shall meet at least twice a year or as often as may be necessary.
- (2) The Chairman may call a meeting and shall be given preference to preside over the meeting. A majority of all its members shall constitute a quorum.

SECTION V. COMPENSATION AND REMUNERATION.

The Chairman, Co-Chairman and Members of the Municipal School Board shall perform their duties as such without compensation or remuneration. Members shall be entitled to necessary travelling expenses and allowances chargeable against the funds of the Municipal School Board.

SECTION VI. REPEALLING CLAUSE.

Previous Executive Orders inconsistent herewith are hereby repealed, superseded and/ or modified accordingly.

SECTION VII. EFFECTIVITY. This Executive order shall take effect immediately.
