**CREATING THE MUNICIPAL PERFORMANCE CHALLENGE FUND (PCF) PROJECT**  
**IMPLEMENTATION UNIT/TEAM**

WHEREAS, the Local Government Unit of Gabaldon, Nueva Ecija has been conferred with the Seal of Good Housekeeping (SGH) being implemented by the Department of the Interior and Local Government (DILG) recognizing the LGUs exemplary performance in the governance areas of development planning, sound fiscal management, transparency and accountability and valuing performance management;
