EXECUTIVE ORDER NO. 05 s. 2016
REORGANIZING THE COMPOSITION OF THE MUNICIPAL PEACE AND ORDER COUNCIL

WHEREAS, Article 116 of RA 7160 states that a Peace and Order Council shall be pursuant to Executive Order No. 309, series of 1988 as amended and the said council shall have the same composition and functions as those prescribed by the stated Executive Order;

WHEREAS, the Municipal Peace and Order Council has tasks to promulgate plans and programs to promote peace and order in the municipality;

WHEREAS, the Municipal Peace and Order Council of the Municipality of Gabaldon, Nueva Ecija needs to be reconstituted due to change in its membership brought about by resignations of few of them from their service or change/transfer of work assignment of others who are heads of other agencies;
