EXECUTIVE ORDER NO. 14 s.2016
REORGANIZING MUNICIPAL ANTI-DRUG ABUSE COUNCIL

Whereas, the Department of Interior and Local Government Unit issued Memorandum Circular Nos.96-227, dated December 2, 1998, 99-226 dated December 21, 1999 and 2001-90, dated July 26, 2001, directing concerned government agencies to immediately reactivate, reorganize and strengthen, or cause the creation of their respective MADAC;

WHEREAS, there is an urgent need to reorganize the same, to make it more effective and proficient in dispensing its duties and functions to the citizenry of Gabaldon Nueva Ecija

NOW, THEREFORE I, ROLANDO S. BUE, Municipal Mayor of Gabaldon Nueva Ecija by virtue of power vested in me by the constitutions and the laws do hereby order;

Section I. That the **MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC)** is hereby reorganized as follows;

SECTION II. DUTIES AND FUNCTIONS. That the MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC) shall have the following duties and responsibilities;

1. Serve as focal point through which various organizations and individuals work together cooperatively in the planning, implementation and evaluation of programs on drug abuse prevention;
2. Provide for an effective mechanism for the coordination of existing services and programs and those which might be developed in the immediate future;
3. Provide for a mechanism to obtain funds, volunteer facilities and technical expertise;
4. Conduct information and education campaign on the ill-effect of illegal drugs, monitor and report to proper authorities, the drug pushers and drug users in this municipality;
5. Prepare a confidential watch list of drug users and pushers found in this locality, to be submitted to the PNP Anti-Illegal Drug Task Force for the latter's validation or verification leading to the arrest and filing of appropriate charges;
6. Perform other related responsibilities as may be assigned by competent authorities.

SECTION III. COMPENSATION AND REMUNERATION. The MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC) shall perform their duties as such without additional compensation or remuneration.

SECTION IV. MEETING. The schedule of the meeting shall depend upon on the behest of the Chairman.

SECTION V. Repealing Clause. All executive orders that are inconsistent therewith shall be deemed revoked, amended and/or amended accordingly.

SECTION VI. EFFECTIVITY. This Executive Order shall take effect .
