**EXECUTIVE ORDER NO. 19 s. 2016**  
**REORGANIZING THE MUNICIPAL HEALTH BOARD**

**WHEREAS**, Section 102 of RA 7160 also known as the Local Government Code of 1991 provides the creation of Local Health Board;

**WHEREAS**, it is imperative to reorganize the same, due to retirement from service of other members and to make it more effective and proficient in dispensing its duties and functions to the citizenry of Gabaldon Nueva Ecija;

**NOW, THEREFORE I, ROLANDO S. BUE**, Municipal Mayor of Gabaldon Nueva Ecija by virtue of powers vested in me by the constitutions and the laws do hereby order that the Municipal Health Board be reorganized, to wit;

**V. COMPOSITION**

**VI. FUNCTIONS:** The functions of the Local Health Board as enumerated under Section 102 of RA 7160 is hereby adopted as follows:

(1) To propose to the sanggunian concerned, in accordance with standards and criteria set by the Department of Health, annual budgetary allocations for the operation and maintenance of health facilities and services within the municipality, city or province, as the case may be;

(2) To serve as an advisory committee to the sanggunian concerned on health matters such as, but not limited to, the necessity for, and application of local appropriations for public health purposes; and

(3) Consistent with the technical and administrative standards of the Department of Health, create committees which shall advise local health agencies on matters such as, but not limited to, personnel selection and promotion, bids and awards, grievance and complaints, personnel discipline, budget review, operations review and similar functions.

**VII. MEETINGS AND QUORUM:**

(3) The board shall meet at least once a month or as often as may be necessary.

(4) A majority of the members of the board shall constitute a quorum but the chairman or the vice chairman must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of a majority of the members shall be necessary to approve such proposals.

**VIII. COMPENSATION AND REMUNERATION:**

The chairman, vice chairman, and members of the municipal health board shall perform their duties as such without compensation or remuneration. Members thereof who are not government officials or employees shall be entitled to necessary travelling expenses and allowances chargeable against the funds of the Municipal Health Board, subject to existing accounting and auditing rules and regulations.

All prior issuances inconsistent with the provisions of this Executive Order is hereby deemed superseded and/ or modified accordingly.

This Executive Order shall take effect immediately.
