EXECUTIVE ORDER NO. 21 s. 2016
CREATING FACT FINDING COMMITTEE TO INVESTIGATE THE COMPLAINT OF MR. CELESTINO
G. MANGULABNAN AGAINST MR. NARDO G. BALDISIMO

WHEREAS, in accordance with Section 444 of RA 7160, the municipal mayor, as the chief executive of the municipal government shall 1.(x) Ensure that all executive officials and employees of the municipality faithfully discharge their duties and functions as provided by law and this Code, and cause to be instituted administrative or judicial proceedings against any official or employee of the municipality who may have committed as offense in the performance of his official duties; 2.(iii) Issue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances;

WHEREAS, the Office of the Municipal Mayor received a letter from Mr. Celestino G. Mangulabnan requesting the Local Chief executive to impose disciplinary action against MR. Nardo G. Baldesimo, Asst. Statistician based on the merit of violation committed by him;

WHEREAS, the Local Chief Executive has all the right to exercise its duties and functions then to create a committee to investigate the complaint, ascertain facts, collect information and provide both parties an impartial resolution of the case;

NOW, THEREFORE I, ROLANDO S. BUE, Municipal Mayor of Gabaldon Nueva Ecija by virtue of power vested in me by the constitutions and the laws do hereby order;

Section I. Creation of Fact Finding Committee to investigate the complaint of Mr. Celestino G.Mangulabnan against Mr. Nardo G. Baldesimo
