EXECUTIVE ORDER NO. 24 s. 2016

“CREATION OF THE MUNICIPAL PUBLIC FINANCIAL MANAGEMENT ASSESSMENT TEAM (MPFMAT)”

WHEREAS, it is stated in the 1987 Philippine Constitution and in the Local Government Code of 1991 (LGC) that the policy of the State to ensure that the territorial and political subdivisions enjoy genuine and meaningful local autonomy in order to attain development as self-reliant communities and be effective partners in the attainment of national goals.

WHEREAS, towards this end, Local Government Units were given more powers, authority, responsibilities and resources to discharge these expanded fiscal, planning and regulatory powers and functions. In order to meet the priority needs and service requirements of the community, there should be an accountable, efficient and dynamic organizational structure and operating mechanism in our LGU.

NOW THEREFORE, I, ROLANDO S. BUE, Municipal Mayor of Gabaldon, Nueva Ecija, by virtue of powers vested in me by the constitutions and laws do hereby order:

Section 1. The Municipal Public Financial Management Assessment Team (MPFMAT) is hereby organized and shall be composed of the following:

Section 2. RESPONSIBILITIES

Duties and functions of the MPFMAT are the following:

1. Orient the LCE and the Local Sanggunian on the administration of the Public Financial Management Assessment Tool (PFMAT), as a credible management tool for planning and implementing reforms, particularly in Public Financial Management (PFM);

2. Ensure the availability of access to required data or information needed for filling out the PFMAT data tables;
3. Measure and analyze the performance of the LGU PFM system using related indicators in every dimension of a good PFM system; and
4. Identify possible solutions and recommendations to attain (a) fiscal discipline, (b) strategic allocation of resources, and (c) efficient service delivery.

Section 3. REMUNERATION

The MPFMAT shall perform their duties as such without additional compensation and remuneration.

Section 4. MEETING

Schedule of meetings shall depend upon on the behest of the team.

Section 5. EFFECTIVITY

This Executive Order shall take effect immediately upon the approval of the undersigned.
