EXECUTIVE ORDER NO.07 s. 2016
REORGANIZING THE LOCAL DEVELOPMENT COUNCIL
AND CONSTITUTING THE EXECUTIVE COMMITTEE THEREOF

WHEREAS, Section 106 of RA 7160 otherwise known as the Local Government Code of 1991 states (a) Each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its sanggunian. For this purpose, the development council at the provincial, city, municipal, or barangay level, shall assist the corresponding sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction .

WHEREAS, Section 111 of the same code states that an Executive Committee shall be created to represent it and act in its behalf when it is not in session;

WHEREAS, the Local Development Council of the Municipality of Gabaldon, Nueva Ecija needs to be reconstituted due to change in its membership brought about by resignations of few of them from their service or change/transfer of work assignment of others who are heads of other agencies;

NOW, THEREFORE I, ROLANDO S. BUE, Municipal Mayor of Gabaldon Nueva Ecija by virtue of powers vested in me by the constitutions and the laws do hereby ordered;

Section I. That the Local Development Council is hereby reorganized;

Section II. COMPOSITION AND MEMBERSHIP. That the composition shall be;

Section III. The duties and functions of the Municipal Development Council shall be to:

1. Formulate long-term, medium-term and annual socio-economic development plans and policies;
2. Formulate medium-term and annual public investment programs;
3. Evaluate and prioritize socio-economic development programs and projects;
4. Formulate local investment incentives to promote the inflow and direction of private investment capital;
5. Coordinate, monitor and evaluate the implementation of development programs and projects and
6. Perform such other functions as maybe provided by law or competent authority.

Section IV. MEETING AND QUORUM. The Local Development Council shall meet once every six months or as often as necessary;

Section V. POWERS AND FUNCTIONS OF THE EXECUTIVE COMMITTEE. The Executive Committee shall;

1. Ensures that the decisions of the council are faithfully carried-out and implemented;
2. Act on matters requiring immediate attention or action by the council;
3. Formulate policies, plans and programs based on the general principles laid down by the council and
4. Act on matters that maybe authorized by the council.

Section VI. SECRETARIAT. A Secretariat is hereby constituted, to be headed by the Municipal Planning and Development Coordinator and shall be responsible for providing technical support, documentation of proceedings, preparation and reports and such other assistance as may be required;

SECTION VII. Previous Executive Orders inconsistent herewith are hereby repealed, superseded and/ or modified accordingly.

Section VIII. EFFECTIVITY. This Executive Order shall take effect immediately.
