EXECUTIVE ORDER NO.20 s. 2016
REORGANIZING THE LOCAL DEVELOPMENT COUNCIL

WHEREAS, Section 106 of RA 7160 otherwise known as the Local Government Code of 1991 states (a) Each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its sanggunian. For this purpose, the development council at the provincial, city, municipal, or barangay level, shall assist the corresponding sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction .

WHEREAS, Section 111 of the same code states that an Executive Committee shall be created to represent it and act in its behalf when it is not in session;

WHEREAS, the Local Development Council of the Municipality of Gabaldon, Nueva Ecija needs to be reconstituted due to changes in its membership brought about by the recent concluded National and Local Election 2016;

NOW, THEREFORE I, ROLANDO S. BUE, Municipal Mayor of Gabaldon Nueva Ecija by virtue of powers vested in me by the constitutions and the laws do hereby ordered;

Section I. That the Local Development Council is hereby reorganized;

Section III. The executive committee shall exercise the following powers and functions:

- (1) Ensure that the decision of the council are faithfully carried out and implemented;
- (2) Act on matters requiring immediate attention or action by the council;
- (3) Formulate policies, plans, and programs based on the general principles laid down by the council; and
- (4) Act on other matters that may be authorized by the council.

Section IV. MEETING AND QUORUM. The Local Development Council shall meet once every six months or as often as necessary;

Section V. SECRETARIAT- Section 113 of RA 7160-There is hereby constituted for each local development council a secretariat which shall be responsible for providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required in the discharge of its functions. The local development council may avail of the services of any non-governmental organization or educational or research institution for this purpose.

SECTION VI. Previous Executive Orders inconsistent herewith are hereby repealed, superseded and/ or modified accordingly.

Section VII. EFFECTIVITY. This Executive Order shall take effect immediately.
