EXECUTIVE ORDER NO. 2017-03

**CREATION OF MUNICIPAL PEACE AND ORDER COUNCIL- TECHNICAL WORKING GROUP (MPOC-TWG)
OF THE MUNICIPALITY OF GABALDON, NUEVA ECIA**

WHEREAS, in accordance with Section 444 of the Republic Act 7160 otherwise known as The Local Government Code of 1991 (a) The municipal mayor, as the chief executive of the municipal government, shall exercise such powers and performs such duties and functions as provided by this Code and other laws;

WHEREAS, Section 116 of the Republic Act 7160 clearly states, There is hereby established in every province, city and municipality a local peace and order council, pursuant to Executive Order Numbered Three hundred nine (E.O. No. 309), as amended, Series of 1988. The local peace and order councils shall have the same composition and functions as those prescribed by said executive order.

WHEREAS, the Department of the Interior and Local Government thru its Secretary and simultaneous Head of National Peace and Order Council, Mel Senen S. Sarmiento issued a Memorandum Circular No. 2015-130 entitled "Guidelines on the Functions of the Peace and Order Councils, Barangay Peace and Order Committees and the Peace and Order Council Secretariats;

WHEREAS, DILG Memorandum Circular No. 2016-141 entitled "Revitalization of the Sub-National Peace and Order Councils was issued on October 7, 2016 by Secretary Ismael D. Sueno, DILG and concurrent Head of National Peace and Order Council.

WHEREAS, this local Government Unit reorganized its Peace and Order Council on March 01, 2016 under Executive Order No.2016-05;

WHEREAS, there is an urgent need to create a Technical Working Group (TWG) of Municipal Peace and Order Council purposely for Peace and Order and Public Safety (POPS) Planning that follows the guidelines, tools and processes prescribed by the DILG;

WHEREAS, the successful performance by line departments and other departments of their mandated tasks can only be assured if auxiliary services are likewise adequately provided;

WHEREAS, the POPS Plan will be the basis of approval for budget allocation for the confidential fund as stated under COA-DBM-DILG-DND-GOCCs Joint Memorandum Circular No. 2015-01 and shall similarly replaced the Integrated Area Community Public Safety Plan (IACPSP).

NOW THEREFORE, I, ROLANDO S. BUE, Municipal Mayor of the Municipality of Gabaldon, Province of Nueva Ecija by virtue of the power vested in me by law, do hereby order:

Section I-Organization and Composition. The Technical Working Group (TWG) for the formulation of the Peace and Order and Public Safety Plan is hereby organized and shall be composed of the following:

Section II. Duties and Functions. The Technical Working Group (TWG) shall undertake the following responsibilities:

- Provide technical assistance in the formulation of a 3-year term-based Peace and Order and Public Safety Plan as prescribed under DILG MC No. 2015-128;
- Present and submit the draft POPS Plan to the Peace and Order Council for review;
- Ensure final approval of POPS Plan to the MPOC for submission and approval of the Sangguniang Bayan and
- Perform other tasks as may be directed by the Council.

Section III. Repealing Clause. All previous executive orders which are in conflict or inconsistent with the provisions of this Order are hereby repealed, amended or modified accordingly.

Section IV. Effectivity. This Executive Order shall take effect immediately.
