EXECUTIVE ORDER NO. 2017-07
REORGANIZING BIDS AND AWARDS COMMITTEE

WHEREAS, pursuant to Article V of RA 9184 otherwise known as "**The Government Procurement Reform Act**" provides the establishment of Bids and Awards Committee in every municipality;

WHEREAS, it is imperative to reorganize the Bids and Awards Committee of this Local Government Unit due to changes of its membership;

WHEREAS, there is an urgent need to reorganize the same in order not to hamper the implementation of Annual Investment Plan and services of all offices of this Local Government Unit. Likewise, to comply with the implementation of Full Disclosure Policy, posting of materials/supplies to be purchased and proposed projects with an amount of Fifty Thousand Pesos and above at PHILGEPS;

NOW THEREFORE, I, ROLANDO S. BUE, Municipal Mayor of Gabaldon, Province of Nueva Ecija, by virtue of power vested in me by existing and applicable laws do hereby order the following;

SECTION I. That the Bids and Awards Committee is hereby reorganized.

SECTION II. COMPOSITION AND MEMBERSHIP. The Bids and Awards Committee shall be composed of the following to wit:

SECTION III. The duties and functions of the Bids and Awards Committee shall be the same as follows:

Advertise and/or post the invitation to bid in PHILGEPS, conduct pre-procurement and pre bid conferences, determine the eligibility of prospective bidders, receive bids, conduct the evaluation of bids, undertake the post-qualification proceedings, recommend award of contracts to the Head of the Procuring Entity or his duly authorized representative: Provided, that in the event the Head of the procuring Entity

shall disapprove such recommendation, such disapproval shall be based only on valid, reasonable and justifiable grounds to be expressed in writing, copy furnished the BAC, recommend the imposition of sanctions in accordance with Article XXIII, and perform such other related functions a may be necessary, including the creation of a Technical Working Committee Group from a pool of technical, financial and/or legal experts to assist in the procurement process.

In proper cases, the BAC shall also recommend to the Head of the Procuring Entity the use of Alternative Methods of Procurement as provided for in Article XVI.

The BAC shall be responsible for ensuring that the procuring entity abides by the standards set forth by RA 9184 and it shall prepare a procurement monitoring report that shall be approved and submitted by the Head of Procuring Entity to the Government Procurement Policy Board on a semestral basis.

Section IV. MEETINGS AND QUORUM. The regular meeting of Bids and Awards Committee shall be depend on the behest of the Chairman or Head of procuring Entity.

SECTION V. REPEALLING CLAUSE.

Previous Executive Orders inconsistent herewith are hereby repealed, superseded and/ or modified accordingly.

SECTION VI. EFFECTIVITY. This Executive order shall take effect immediately.
