EXECUTIVE ORDER NO. 2018-21
CREATION OF LOCAL CULTURE AND THE ARTS COUNCIL
OF THE MUNICIPALITY OF GABALDON NUEVA ECIA

Whereas, the Department of the Interior and Local Government Unit issued a Memorandum Circular No 2017-133 enjoining all provinces, cities and municipalities to create their own Local Culture and The Arts Council for the purpose of protecting, preserving and promoting cultural heritage and ethnicity of local communities;

Whereas, the National Cultural Heritage Act of 2009 also known as Republic Act 10066, provides for the protection and conservation of the national cultural heritage, strengthening the National Commission for Culture and the Arts (NCCA) and its affiliated cultural agencies;

Whereas, the Municipal Government of Gabaldon Nueva Ecija is considered as one of the designated cultural agencies, signifies sincere support to the above stated Memorandum Circular for the preservation, protection and promotion of our own cultural heritage and ethnicity and values the importance for our local community;

WHEREAS, this Local Government Unit believes that the successful performance by line departments and other departments for their mandated tasks can only be assured if auxiliary services are likewise adequately provided;

NOW THEREFORE, I, **ROLANDO S. BUE**, Local Chief Executive of Municipality of Gabaldon, Nueva Ecija, by virtue of the power vested upon me by Sec. 444, par 2 (iii) of the Local Government Code of the Philippines, do hereby order the following:

SECTION I. That the Local Culture and the Arts Council of the Municipality of Gabaldon Nueva Ecija is hereby created.

SECTION II. COMPOSITION AND MEMBERSHIP. The Local Culture and The Arts Council of the Municipality of Gabaldon Nueva Ecija shall be composed of the following to wit:

SECTION III. FUNCTIONS

1. Prepare an annual plan on culture, arts and cultural heritage consonant with the Philippine Development Plan for Culture and the Arts, to be integrated in the local development plan and considered in the annual appropriation ordinances;
2. Formulate programs and recommendations to develop and sustain local cultural and artistic talents, cultural industries, traditional and contemporary arts and crafts and their processes;
3. Coordinate with the appropriate affiliated cultural agencies of the National Commission for Culture and the Arts (NCAA) for the conservation and monitoring of national cultural properties found in the LGU;
4. Conduct cultural events such as cultural festivals, competition, lectures, seminars and symposia;
5. Identify such other programs and activities for the promotion of local cultural heritage and arts.
6. Ensure the protection, preservation, conservation and promotion of the local cultural and historical heritage;
7. Declare and maintain Local Heritage Zones;
8. Establish a Local Registry of Cultural Property.

SECTION IV. EFFECTIVITY

This Executive Order shall take effect immediately.
