EXECUTIVE ORDER NO. 2018-08
CREATION OF CHILD FRIENDLY LOCAL GOVERNANCE AUDIT (CFLGA)
OF THE MUNICIPALITY OF GABALDON NUEVA ECIJA

WHEREAS, the creation of Child Friendly Local Governance Audit (CFLGA) in this municipality is very imperative to conform to the existing laws that protect and promote the welfare of the children and correspond to its objective, To provide the mechanics on the conduct of Child-Friendly Local Governance Audit and To institute an audit system for measuring local governance performance in the delivery of services that would generate positive results for children;

WHEREAS, the Child Friendly Local Governance Audit (CFLGA) has Twelve Assessment Criteria, These are 1) Percentage reduction in the deaths among children below five years old; 2) Percentage reduction in the number of children under six with below normal weights; 3) Percentage increase in the number of 3-4- year-old children attending center-based day care services; 4) Completion rate for elementary schooling; 5) Absence of child labor or percentage reduction in child labor cases; 6) Percentage reduction in the number of children victims of violence, abuse, neglect and exploitation (all forms, including physical violence, sexual abuse, and exploitation, and trafficking in persons). 7) Safety measures for children in the community and schools; 8) Extent of mainstreaming of Children's rights to survival, development, protection and participation in the core development agenda of LGUs; 9) An ordinance establishing Barangay Violence Against Women and their Children (VAW/C) Desks; 10) Philhealth accreditation in its main health facility or rural health unit for Maternal Care Services and Primary Care; 11) A Local School Board (LSB) Plan that is aligned with the School Improvement Plan (SIP); 12) Completed at least 70% of its LSB Plan.

NOW, THEREFORE I, ROLANDO S. BUE, Municipal Mayor of Gabaldon Nueva Ecija by virtue of power vested in me by the constitutions and the laws do hereby order

SECTION I. Child Friendly Local Governance Audit (CFLGA) of the Municipality of Gabaldon, Nueva Ecija is hereby created

SECTION II. COMPOSITION. The Creation of Child Friendly Local Governance Audit (CFLGA) of the Municipality of Gabaldon, Nueva Ecija shall be composed of the following to wit:
