EXECUTIVE ORDER NO. 2019-05
REIMPLEMENTING EXECUTIVE ORDER NO. 26 S. 2017
ISSUED BY HIS EXCELLENCY RODRIGO ROA –DUTERTE,
PRESIDENT, REPUBLIC OF THE PHILIPPINES

WHEREAS, in accordance with Section 444 of the Republic Act No. 7160 otherwise known as The Local Government Code of 1991 (a) The municipal mayor, as the chief executive of the municipal government, shall exercise such powers and performs such duties and functions as provided by this Code and other laws;

WHEREAS, Republic Act No. 9211 otherwise known as Tobacco Regulation Act of 2003, **Section 2.** Policy—It is the policy of the State to protect the populace from hazardous products and promote the right to health and instill health consciousness among them, as well as, it is consistent with the constitutional ideal to promote the general welfare, to safeguard the interests of the workers and other stakeholders in the tobacco industry. For these purposes, the government shall institute a balanced policy whereby the use, sale and advertisements of tobacco products shall be regulated in order to promote a healthful environment and protect the citizens from the hazards of tobacco smoke, and at the same time ensure that the interests of tobacco farmers, growers, workers and stakeholders are not adversely compromised. Whereas, Section 5 of the said act mentioned the prohibition of smoking in certain public places and Section 6, clarifies the Designation of Smoking and Non-Smoking Areas;

WHEREAS, Republic Act 8749 otherwise known as Philippine Clean Air Act of 1999, prohibits smoking inside enclosed public places and other enclosed areas, and in all forms of public transportation;

WHEREAS, this Local Government Unit manifests support to Philippine Health Agenda of Duterte Administration, ALL FOR HEALTH TOWARDS HEALTH FOR ALL and to the Executive Order No. 26 Series 2017. Hence, it is very imperative to implement the provisions of the said Executive Order within the jurisdiction of this municipality for the benefit of all concerns;

NOW THEREFORE, I, ATTY. JOBBY PETINES EMATA, Local Chief Executive of the Municipality of Gabaldon, Province of Nueva Ecija by virtue of the power vested in me by law, do hereby Reimplemented the **Executive Order No. 26 s. 2017 issued by His Excellency Rodrigo Roa – Duterte, President, Republic of the Philippines**

Section I-PROHIBITION- Smoking of all forms of cigarette is hereby prohibited to the premises of all government and private offices such as:

- NEECO II-Area 2
- Local Government Unit
- NEUST Gabaldon Campus
- MEDICARE Community Hospital
- Bureau of Fire Protection-Gabaldon

- Public Market
- Public Transport Terminal
- Rural Health Unit
- F.Buencamino Integrated School
- All Barangay Halls
- Birthing Station
- Gabaldon Vocational Agriculture High School
- Ligaya National School
- All Elementary Schools
- All Covered Courts
- All waiting Sheds
- All Day Care Centers
- All Private Clinics-dental clinic, maternity clinic, emergency clinic and laboratories
- All Gasoline Stations
- Gabaldon PNP Station
- BUB Water Supply Facility
- Terminal of Tricycles
- All Forms of Public Transportation
- All Computer Shops
- Old Market Building

Section II-DESIGNATION OF SMOKING AREA-

- I. There shall be one smoking area for each establishment which will be designated by the head of agencies, manager/owner of private offices. It shall bear signage that such area is the designated smoking area and it is fifty meters away from the respective offices.

- II. This Local Government Unit has designated smoking area as its smoking area at the northern side of the municipal building.

Section III- EFFECTIVITY – This Executive Order shall take effect immediately
