



EXECUTIVE ORDER NO. 2019-09

REORGANIZING THE LOCAL DEVELOPMENT COUNCIL OF THE MUNICIPALITY OF GABALDON, NUEVA ECIJA

WHEREAS, Section 106 of RA 7160 otherwise known as the Local Government Code of 1991 states (a) Each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its sanggunian. For this purpose, the development council at the provincial, city, municipal, or barangay level, shall assist the corresponding sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction;

WHEREAS, Section 111 of the same code states that an Executive Committee shall be created to represent it and act in its behalf when it is not in session;

WHEREAS, the Local Development Council of the Municipality of Gabaldon, Nueva Ecija needs to be reorganized due to the changes in its membership;

NOW, THEREFORE I, ATTY. JOBBY PETINES EMATA, Local Chief Executive of the Gabaldon Nueva Ecija by virtue of power vested in me by the constitution and the laws do hereby order;

SECTION I. THAT THE LOCAL DEVELOPMENT COUNCIL OF GABALDON, NUEVA ECIJA IS HEREBY REORGANIZED;

SECTION III. THE LOCAL DEVELOPMENT COUNCIL SHALL EXERCISE THE FOLLOWING POWERS AND FUNCTIONS:

1. Formulate long term, medium-term, and annual socio-economic development plans and policies;
2. Formulate the medium-term and annual investment programs;
3. Appraise and prioritize socio-economic development programs and projects;
4. Formulate local investment incentives to promote the inflow and direction of private investment capital;
5. Coordinate, monitor, and evaluate the implementation of development programs and projects; and
6. Perform such other functions as may be provided by law or component authority

SECTION IV. MEETING AND QUORUM. The Local Development Council shall meet once every six months or as often as necessary;

SECTION V. SECRETARIAT- Section 113 of RA 7160-There is hereby constituted for each local development council a secretariat which shall be responsible for providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required in the discharge of its functions. The local development council may avail of the services of any non-governmental organization or educational or research institution for this purpose.


