**EXECUTIVE ORDER NO. 2019-12**  
**REORGANIZING MUNICIPAL ANTI-DRUG ABUSE COUNCIL**

**WHEREAS**, the Department of Interior and Local Government Unit issued Memorandum Circular No.96-227 dated December 2, 1998,99-226 dated December 21, 1999 and 2001-90, dated July 26, 2001, directing concerned government agencies to immediately reactive, reorganize and strengthen, or cause the creation of their respective MADAC;

**WHEREAS**, the Municipal Anti-Drug Council of the Municipality of Gabaldon, Nueva Ecija needs to be reorganized due to changes in its membership brought about by the recent National and Local election and change/transfer of work assignments of other members who are heads of other agencies;

**NOW THEREFORE**, I, **ATTY. JOBBY PETINES EMATA**, Municipal Mayor of Gabaldon, Nueva Ecija by virtue of powers vested in my by the constitutions and the laws do hereby order;

Section I. That the **MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC)** is hereby reorganized as follows;

**SECTION II. DUTIES AND FUNCTIONS.** That the MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC) shall have the following duties and responsibilities;


1. Serve as focal point through which various organizations and individuals work together cooperatively in the planning, implementation and evaluation of programs on drug abuse prevention;
2. Provide for an effective mechanism for the coordination of existing services and programs and those which might be developed in the immediate future;
3. Provide for a mechanism to obtain funds, volunteer facilities and technical expertise;
4. Conduct information and education campaign on the ill-effect of illegal drugs, monitor and report to proper authorities, the drug pushers and drug users in this Municipality;
5. Prepare a confidential watch list of drug users and pushers found in this locality, to be submitted to the PNP Anti-Illegal Drug Task Force for the latter's validation or verification leading to the nearest and filling of appropriate charges;
6. Perform other related responsibilities as may be assigned by competent authorities.

**SECTION III. COMPENSATION AND REMUNERATION.** The MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC) shall perform their duties as such without additional compensation or remuneration.

**SECTION IV. MEETING.** The schedule of the meeting shall depend upon on the behest of the chairman.

**SECTION V. EFFECTIVITY.** This Executive Order shall take effect immediately until further revoked or amended by the undersigned.
