

### Invitation to Bid

for Embankment of water flood control (Gabion Dike), as follows;

1. Embankment of additional water flood control (Gabion Dike) – Danglan Creek, South Poblacion
2. Embankment of additional water flood control (Gabion Dike) – Bitunin Creek, Brgy. Calabasa
3. Embankments of water flood control (gabion dike) – Segum Creek, Brgy. Bagting

1. The **LGU Gabaldon**, through the **Budget for the contract approved by the respective Sanggunian for the calendar year 2021** intends to apply the sum of **One Million Five Hundred Twenty Thousand Eight Hundred Sixty Two pesos and 23/100 only (1,520,862.23)** being the Approved Budget for the Contract (ABC) to payments under the contract for Embankment of water flood control (Gabion Dike), as follows:

1. Embankment of additional water flood control (Gabion Dike)  
– Danglan Creek, South Poblacion P 1,220,862.23
  2. Embankment of additional water flood control (Gabion Dike)  
– Bitunin Creek, Brgy. Calabasa P 100,000.00
  3. Embankments of water flood control (gabion dike)  
– Segum Creek, Brgy. Bagting P 200,000.00
- with **Project Identification Number 01282021-02**, Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The **LGU GABALDON** now invites bids for the above Procurement Project. Completion of the Works is required as follows:

1. Embankment of additional water flood control (Gabion Dike)  
– Danglan Creek, South Poblacion 90 calendar days
2. Embankment of additional water flood control (Gabion Dike)  
– Bitunin Creek, Brgy. Calabasa 60 calendar days
3. Embankments of water flood control (gabion dike)  
– Segum Creek, Brgy. Bagting 60 calendar days

3. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).


4. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

5. Interested bidders may obtain further information from **LGU GABALDON** and inspect the Bidding Documents at the address given below from **Monday to Friday at 8:00 am to 5:00 pm**.

6. A complete set of Bidding Documents may be acquired by interested bidders on *January 29, 2021* from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos Only (P 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees and it will be presented in person.
7. The **LGU GABALDON** will hold a Pre-Bid Conference<sup>1</sup> on **February 4, 2021** at **Municipal Session Hall, Municipal Building, Gabaldon, Nueva Ecija**, which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **February 16, 2021, 10:00 am**. Late bids shall not be accepted.
9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 15**.
10. Bid opening shall be on **February 16, 2021, 10:20 am** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
11. The **LGU GABALDON** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders
