

**INVITATION TO APPLY FOR ELIGIBILITY AND TO BID**

The **LGU-Gabaldon**, through its Bids and Awards Committee (BAC), invites suppliers/manufacturers/distributors/contractors to apply for eligibility and if found eligible, to bid for the hereunder contract:

Name of Contract : **Construction of National Child Development Center at Brgy. South Poblacion**

Location : **Brgy. South Poblacion, Gabaldon, Nueva Ecija**

Brief Description : **Construction of National Child Development Center at Brgy. South Poblacion**

Approved Budget for the Contract (ABC) : **Two Million Four Hundred Ninety Nine Thousand nine hundred fifty one pesos and 61/100 only (P 2,499,951.61)**

Contract Duration : **forty five (45) calendar days**

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. The post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).


