

INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The **LGU-Gabaldon**, through its Bids and Awards Committee (BAC), invites suppliers/manufacturers/distributors/contractors to apply for eligibility and if found eligible, to bid for the hereunder contract:

Name of Contract : **Purchase and Delivery of two (2) units Farmal Tractor, and two (2) units Mini Dumptruck**

Location : **LGU - Gabaldon, Nueva Ecija**

Brief Description : **Purchase and Delivery of two (2) units Farmal Tractor, Disc Plow and Disk Harrow, and two (2) units Mini Dumptruck, specification are stated below,**

1. **Mini Dumptruck: 6 wheeler, 10ft, M/T, Diesel Engine**
2. **Farmal Tractor: Direct Injection, Vertical, Water cooled 4 cycle diesel, 4 cylinders, 36.5 kw (48.93 HP) engine gross power,**
3. **Disc Plow**
4. **Disck Harrow**

Approved Budget for the : **Four million five hundred thousand pesos only (P 4,500,000.00)**

Contract (ABC)

Contract Duration : **twenty (20) calendar days**

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. The post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).


